

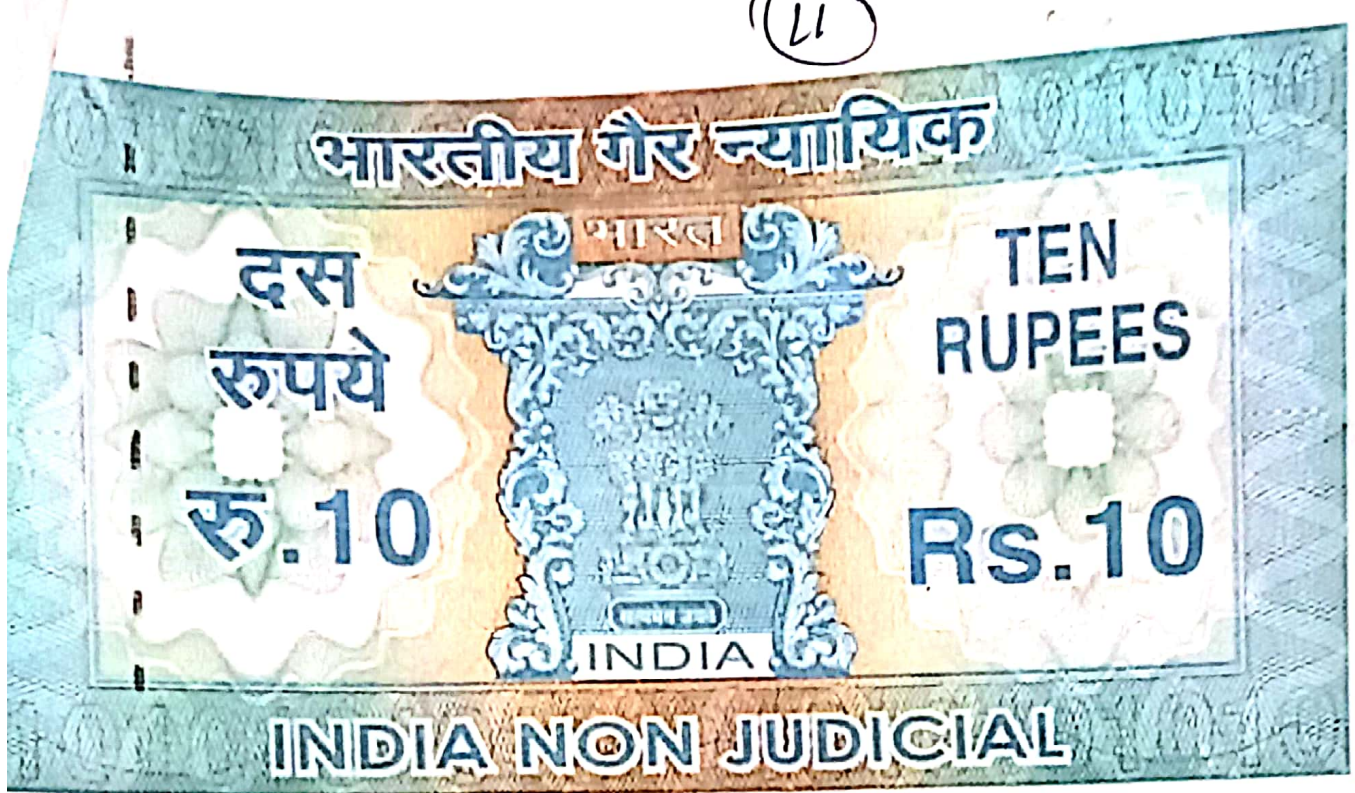

- xxiv) To establish, receive, accept the endowment, gifts, donation, contributions, grants funds fee in cash, material of kind from individuals, institutions, organizations, societies, funds foundations, companies, trusts, government, public or private bodies from India and abroad for fulfillment and attainment of the objectives and aims of the foundation.

- 3- Sri Shantnu Mishra S/o Late Sri Judavan Prasad Mishra

ii) The Trustees shall hold office during their life unless any of them desires to be discharged of his duties or becomes mentally or physically incapable of working or is declared insolvent or is convicted of a criminal offence.

iii) In the event of a vacancy arising in the Board of Trustees for whatever reasons, the remaining Trustees shall co-opt another major male or female person out of the family members of that persons to fill up the vacancy.

iv) The number of trustee shall at one time be not less than two and more than eleven.

v) The number of Trustee shall work in an honorary capacity, but they shall be entitled to re-imbrues expenses incurred by them in the conduct of their duties or in promotion of the objects of the Trust or on behalf of the trust. No Trustee shall be entitled to take loan from the trust or on behalf of the trust. No trustee shall be entitled to take loan from the trust or to take any advantage for himself or any member of his family in whatever from the trust.

vi) A Trustee who by his conduct as a trustee or in his personal life adversely reflects on the reputation of the Trust may be asked by the Board of Trustees by a resolution passed by a majority to submit his/her resignation, failing which he/she shall cease to be a Trustee with effect from the date of passing of such resolution.

vii) The trustees may institute, conduct defined compound or abandon any legal procedure by or against the Trust or Trustees and allow time and indulgence for payment or satisfaction of any dept due or for any claims or demands by or against the trust

viii) To arrange for and/or Authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the TRUSTEES by Smt. Sarika Mishra Trustee or trustees appointed by the board or trustees from time to time and to

make the same effective and binding as if the said agreement, contract, documents or paper or writing were signed by all the trustees.

- ix) The trustees of the trust may obtain payments of money from all courts and Department of the State and Central Government including local authority or authorities.
- x) The trustees may purchase, construct, alter lease, and rent partly or fully immovable or movable property from time to time. They shall have power to sell movable or immovable property of the trust by two third of the majority in the best interest of the Trust as and when necessary and to use these proceeds for the objects of the trust only.
- xi) The trustees may authorize any of the trustees to appear before the registrar of sub registrar of any other officials appointed for registration of deeds, documents and other instruments and to execute, present, admit and register or cause to be registered any deed, documents etc. in which the trust is interested or involved.
- xii) The trustees shall be empowered to employ whole time or full time or part time servants, clerk, doctors, nurses, technicians, lawyers, auditor, engineers and other professionals and personnel according to the requirement of various institutions that may from time to time. The trustees shall have power to accept honorary services or any person volunteering to do the works in the trust or in the charitable institutions run by the trust. The trustees shall have full disciplinary control and powers over such staff, employees, workers honorary or otherwise.
- xiii) To appoint or make provision for the appointment of a sub-committee of trustees or other to attend to or supervise or conduct specified jobs or functions in such manner and under such rules & regulation as the trustees may prescribe.
- xiv) The trustees may establish their Branch office or offices at such place or places may change such places from time to time as they may think fit.
- xv) The trustees shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the trust estate and/or the trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.
- xvi) The trustees may from to time frame schemes and rules and regulations to carry out the object of the trust and for managing the affairs of the trust and

otherwise for giving effect to the object and purposes of the trust and to vary the same from time to time as the trustees may in their discretion deem fit & proper.

xvii) THE TRUSTEES shall be entitled at their discretion from time to time to start, discontinue, abolish and re-start any charity or charitable institution, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust property or income for any particular object or objects.

xviii) The TRUSTEES may reimburse themselves and pay and discharge out of the TRUST FUND all expenses incurred by them in or about the execution of the trust or any of their duties under these presents including travel expenses, but will not be entitled to any remuneration.

xix) Any trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.

### 7- MEETINGS

i) The trustees may meet together as and when they may think necessary. But they shall hold at least two meeting in a year.

ii) The quorum at a meeting of the trustees shall be two when the strength of the trustee is less than four. The quorum shall, be three if the strength is more than four.

iii) Smt. Sarika Mishra shall preside over all meetings of the Trust. In case he is not present the-Trustees present may select one of them as chairman of the meeting.

That trustees shall act according to be decisions of the majority of the trustees when the trustee are not unanimous the chairman shall have the casting vote in case of tie.

iv) There will be no need of a quorum for adjourned meeting wherein agenda of last meeting will be discussed or decided.

v) Notice of the meeting of the TRUSTEES and all communications may be sent to the TRUSTEES at their addresses registered with and being in the records of the trust, from time to time.

vi) All meetings of the trust shall be held at such place and at such time as the trustees shall decide from time to time. However at least 2 TRUSTEES can request the Chief Trustee for an extraordinary meeting art giving notice to all the trustees.

10. ACCOUNT AND AUDIT: The Trustees shall maintain proper accounts. They will be annually audited by chartered accountant appointed by the Board of Trustees fixing his remuneration.

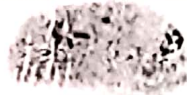
11- The necessary registration under the Income tax act and under other applicable laws to be got done.
